**TERMS AND CONDITIONS**

1. The award of the higher grade will be considered as personal scale to the incumbents.
2. No premature increment will be admissible at the time of pay fixation in the higher grade.
3. The teachers will continue to hold the same posts on award of next scale. However, placement in the next higher scale will be differentiated with Level-I & Level-II teachers.
4. The inter-se-seniority of the teacher in their respective category shall remain intact and the incumbents shall move from one step to higher and then next higher with reference to their inter-se-seniority.
5. The award of higher scales under this scheme will not create any right to claim higher post. The appointment / promotion against in-service quota shall remain intact under the existing rules / instructions already in practice.
6. The award of pay package 2007 in subject to physical verification of his appointment order as SST on regular basis, service book by the head of institution. If there is any discrepancy the head of institution shall immediately report the matter for withdrawal of pay package 2007.
7. An under taking from the concerned teacher may also be obtained by the head of institution to the effect that any wrong award may be withdrawn / cancelled and amount paid may be recovered from the concerned teacher if any mistake / error / omission was found in award of pay package 2007 at any later stage. If there is any such discrepancy found the head of institution / officer in charge shall immediately refer the case to the DEO / EDO Lahore for taking necessary action.
8. It may also be ensured that there is no regular enquiry pending or in progress. Moreover, there is no adverse remark in the ACR against the teachers who has been awarded pay package 2007 in the above mention orders. If so, the case will be brought in the notice of DEO / EDO for with holding the award of pay package 2007.
9. If any omission / commission are found in award of pay package 2007 at later stage the orders will be withdrawn.
10. The Head of Institutions ensured and clarify that the incumbent is working as SST at the date of issuance of this order.
